Senator Cardin Visits a HUBZone Business in West Baltimore to Assure Small Business Owners That He Is In Support Of Creating More Opportunities for HubZone Businesses and Ex-Felons

On a gray rainy morning in West Baltimore the sun was shining bright, as U.S. Senator Benjamin Cardin, D, Maryland returned to his roots where he grew up as a lad. The site was the headquarters and office of Allen & Son Moving & Storage Casino Supplies/Services which is located in a historically underutilized business zone (HUBZone) and a different place where Senator Cardin as a youth spread his wings.

Senator Cardin came to shed light on the positive effects for small and minority businesses on the recent health care bill signed into law by president Obama. Senator Cardin also addressed issues dealing with HUB Zone business utilization on federal contracts which delighted the majority of the attendees. In addition, Senator Cardin addressed legislation he will introduce to congress calling for debundling of large federal contracts and providing direct aid to urban centers for training returning ex-felons. To everyone's delight Senator Cardin said he is working with Governor O'Malley in bringing TARP funds to the state that will match state funds to open up capital to small businesses. The amount in question will total in the hundreds of millions of dollars. Senator Cardin said he favors all three methods proposed to get funds to businesses either by SBA guaranteed loans, funding by commercial and community banks or direct loans by the SBA itself. He reiterated that "We need to get the funds to the deserving businesses so they can succeed."

It made my wife and me very proud to host this historic meeting."

Mr. Johnson said, "Senator Cardin provided hope for my business to continue hiring ex-felons. His pledge to fund more resources for the training and development can only help in turning around lives."

Mr. Ogden said, "If it takes a special business to be located within a HUBZone because of the stigma of the location, but for Kayden it was one of the wisest decisions we've made, and if Senator Cardin follows through on his pledge to widen HUBZone utilization on federal contracts we will do even better."
